General Information

This course will count as ½ unit of elective credit, and is graded as a “PASS/FAIL Course. This credit counts toward high school graduation requirements. In order to successfully complete this course, the following criteria will be met:

- 56 hours of instruction including 12 research articles.
- Successful completion of all materials including exams, section reviews, and research articles.
- Students will need to achieve a 70% grade to pass the course.
- Must be 15 years of age by the end of the class to enroll.

CLASS GUIDELINES
